UNITED NATIONS CONVENTION ON CONTRACTS FOR THE  
INTERNATIONAL SALE OF GOODS  
CONCLUDED AT VIENNA ON 11 APRIL 1980

ACCESSION BY SPAIN AND THE UNION OF SOVIET SOCIALIST REPUBLICS

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 24 July and 16 August 1990, respectively, the instruments of accession by the Governments of Spain and the Union of Soviet Socialist Republics to the above-mentioned Convention were deposited with the Secretary-General.

The instrument of accession by the Government of the Union of Soviet Socialist Republics contains the following declaration:

(Translation) (Original: Russian)

In accordance with articles 12 and 96 of the Convention, the Union of Soviet Socialist Republics declares that any provision of article 11, article 29 or Part II of the Convention that allows a contract of sale or its modification or termination by agreement or any offer, acceptance or other indication of intention to be made in any form other than in writing does not apply where any party has his place of business in the Union of Soviet Socialist Republics.

In accordance with article 99 (2), the Convention will enter into force for Spain on 1 August 1991 and for the Union of Soviet Socialist Republics on 1 September 1991, i.e. the first day of the month following the expiration of twelve months after the date of deposit of said instruments.
